**Mode of Action:** Trigard® 75 WP inhibits the development of fly larvae. Emergence of adults is suppressed or incomplete. Adults are not killed but reduced egg hatch has been observed. It penetrates the leaves when applied as a foliar spray and is rapidly absorbed by the roots when applied to the soil.

**Spectrum of Activity:** Effective on dipterous larvae, especially on Liriomyza trifolii, Liriomyza huidobrensis and related leaf miner species.

**DIRECTIONS FOR USE**  
Dosage and Timing

**Snow peas and French beans**  
Rate: 150-300 g/ha.  
Spray volume: 200-800 l/ha.  
Knapsack sprayer: Use 9 g/15 lt knapsack and 12 g/20 lt knapsack. This is based on a spray volume of 500 litres per hectare.  
Spray interval: 10-14 days.  
Number of sprays per season: maximum 3 sprays.

**Spray Volume**  
For vegetables use at least 200-800 l/ha depending on density of foliage.

**Mixing:** Pre-mix the required quantity of product with a small volume of water. Add the slurry to clean water in the half-filled spray tank. Maintain agitation while topping up. Always stir the spray mixture well and apply within a few hours.

**Spraying Equipment:** Trigard® 75 WP can be applied with conventional tractor boom sprayers, motorized knapsack sprayers. The equipment must be properly calibrated to provide thorough and even coverage of the whole plant, in particular also of the lower plant parts.

**Storage:** Store away from sun and damp. Store in original tightly closed containers in a well-ventilated area. Avoid storage above 35°C. Store under lock and key, away from children, animals and unauthorised persons.

**Limitations:** A potential exists for Liriomyza species to develop cyromazine-resistant strains. Apply this product with restraint and according to directions on the label to decrease the risk of resistance developing. It is recommended to use Trigard® 75 WP in rotation with Dynamec®, to control leafminers and avoid build-up of resistance.

**Pre-Harvest Interval**  
Snow Peas and French Beans: 14 days.

**Operator Safety:** The product is irritating to eyes, skin and respiratory system. Avoid getting product in contact with skin, eyes or clothing. Do not inhale dust or spray mist. Wash hands and face before eating, drinking, or smoking. If indisposition occurs, stop work immediately and apply first aid measures. Wear protective clothing (overalls, gumboots, face shield, hat or cap) when spraying. Wash off splashes of concentrate immediately. After work, wash entire body thoroughly. Clean work clothing and protective equipment immediately after work.

**Leakage and Spillage:** Remove heavily contaminated soil and dispose in a safe place away from water supplies. Spillage: soak up with sand, sawdust, soil or an oil binding agent. Collect contaminated material thoroughly and dispose in a safe place or put in a waste bin or plastic bag, mark it and dispose in accordance with the National Legislation on disposal of pesticides. Treat spill area with plenty of water. Do not re-use spill product.

**Environment and Wildlife:** At the recommended rates Trigard® 75 WP is practically non-toxic to fish, birds and bees. Do not contaminate stagnant water or running water by disposal of product waste. The treated area must not be grazed, and no food or feed should be collected from it for a period corresponding to the pre-harvest interval. Do not enter treated areas before the spray has completely dried.
